She represents the Institution of Fire Engineers, Singapore as the Review Committee for the Singapore Code of Practice for Fire Precautions in Rapid Transit Systems and one of the pioneers in navigating the use of parametric design fire for performance-based fire engineering design of timber buildings in Singapore.
