Speaker's Profile

Mr David Goh is the Managing Director of Vanguard Fire Systems Pte Ltd. He has 40 years of experience and technical knowledge in Fire Alarm Systems and Emergency Voice Communication Systems. Leading a technical and marketing team which were responsible for fire alarm and EVC control panel manufacturing, systems design / equipment supplies and meeting statutory technical requirements etc.

He is the Convener of Working Group for SS546: 2022 and SS645:2019

He also serves as Council Member of the Institution of Fire Engineers, Singapore and the Vice President of Fire Safety Managers' Association Singapore (FSMAS).

His presentation will focus on the knowledge information which a Fire Safety Manager would need to know on SS546 20222.

Principal Consultant in the Consultation and Fire Safety Engineering Branch, Fire Safety Department. His core duties include providing consultation services on fire safety design matters to Qualified Persons, building owners and developers. He has also held various positions previously, including Senior Staff Officer for Exercise Planning at Training Dept and Commander Clementi Fire Station.

His presentation will cover the amendments to the Code of Practice for Fire Precautions in Buildings (Fire Code). The amendments consist of numerous new provisions/ clarifications/ relaxations to the

existing clauses of the Fire Code.

Also, he will be sharing the common consultation queries that SCDF received during consultation. Common queries include submission to SCDF for approval, interpretation of Fire Code clauses, extent of QP's responsibilities in A&A works, and etc

Er Yee Poh Kin, Principal of New Universal Solution, boasts over three decades of extensive experience in fire engineering consultancy. Currently serving as a member of the SCDF Fire Code Review Committee and Fire Safety Committee. Additionally, Er Yee holds key roles such as convener for Enterprise Singapore's working group reviewing SS 489-Specification for Fire Shutters and member of working groups for Specification for Fire Damper and SS578- Code of Practice for Use and Maintenance of Portable Fire Extinguishers.

He serves as the Vice President of the Institution of Fire Engineers (IFE) Singapore and is a Committee Member in the Institution of Engineers Singapore (IES) and the Fire Safety Managers' Association Singapore (FSMAS).

His presentation covers the types and installation guidelines of various fire-smoke dampers, emphasizing the imperative of regular testing and maintenance. He will also focus on the implementation of the Product List Scheme by SCDF and highlight the importance of meticulous adherence to guidelines for optimal efficacy.

CPT Joyce Ng obtained her M.Arch from NUS in 2015. She has been a consultant with the Industrial and Institution Design Branch since



2021. Her role involves processing waivers, auditing plans, and conducting site inspections.

Plans of fire safety works that are certified by Qualified Persons and submitted to SCDF for approval may be subject to audit checks. CPT Joyce will be sharing on the common non-compliances found for commercial and industrial projects during SCDF's audits as well as key items that Qualified Persons should look out for to improve the quality of submissions.

Er Ho Victor is a council member of IFES. He is also a Director of HiLT Pte Ltd, a fire engineering consultancy practice. He has been actively involved in the fire safety consultancy for the past 29 years. He is a member author of the inaugural Singapore Fire Engineering Guidelines 2015 and Singapore Standard SS 634 – Fire Safety Code of Practice for open plant structures in oil, chemical, and process industries. He recently completed his term in the review of SS 532 - Code of Practice for Flammable Storage and is currently working on the Code of Practice Fire Precaution for Road Tunnels and the revision of CP 52 - Code of Practice for automatic fire sprinkler system. On the international front, he sits on the technical committee of Underwriters Laboratories (UL) -Standard for Electrical Systems for eBikes TC2849 (Voting member) and Technical Committee for Energy Storage Systems and Equipment, TC 9540 (non-voting).

This sharing session aims to introduce some of the salient clauses in the revised SS 532 Code for the storage of flammable liquids which was recently launched on 18 March 2024. It also gives a recap of the overall scope of the code and some of the challenges facing the industry concerning Polyfluoroalkyl Substances (PFAS) in the firefighting industry.

Er Shyam Dayanandan is a Professional Engineer, Fire Safety Engineer & Partner @ C2D Solutions Pte Ltd, a Fire Safety & Mechanical Consultancy for the Built Environment. He has been actively involved in the fire safety engineering & mechanical consultancy for the past 21 years.
